Renewal Notice

In order to preserve the high standards endowed by certification with PWS, SWSPCP, Inc., certification renewal is required (Section 26 of Standing Rules). Beginning June 1, 2001, all newly certified PWS are required to renew certification at five year intervals from the original certification date. Individuals originally certified prior to June 1, 2001, are also required to renew their certification.

When you receive your renewal notice please take some time and promptly respond to ensure your recognition as a professional in the field of wetland sciences continues. We believe that through this process we can all work together to maintain the highest standards for our profession and continue to increase the value of our certification.
