The President's Corner

SWSPCP has been pretty busy this year! We have had several Board meetings and there are several committees hard at work. The committees you are most likely to be familiar with include the Certification Panel and the Certification Renewal Committee. These committees work very hard reviewing and approving applications for Professional Wetland Scientists (PWS), Wetland Professionals in Training (WPIT), and renewing certifications for existing PWSs. Applications for PWS and WPIT continue to grow. For example, since January 1, 2013, we have received 77 applications for PWS and WPIT compared to 60 applications for the same time last year. This past year has also been a banner year for certification renewals (including mine). At present there are 1,394 Professional Wetland Scientists.

A new and very active committee has been the Professional Short Course Review Panel. This panel has been working on developing a Professional Short Course Pre-approval Program wherein SWSPCP will pre-approve continuing education programs. See the related article in this newsletter.

The SWSPCP became accredited by the Council of Engineering and Scientific Specialty Boards (CESB) a few years ago. We attended their annual conference in March and SWSPCP will continue to evolve to maintain certification, including revising our Body of Knowledge and working on defining our continuing education credits. In addition, we are looking into establishing a Legislative Tracking Committee so that we can assist our members in tracking legislation that affects us in various states.

We are also getting ready for the SWS Annual Meeting in Duluth and we hope you'll be able to attend. We will have a booth where you can come by and meet Board members and the wonderful staff from our

management company, The Center for Association Resources. As we did last year, there will be SWSPCP logo items for sale and we'll have daily raffle items, so come by and introduce yourself.

During the Annual Meeting, we'll be holding an Ethics Session, which is split into two sessions: Monday June 3 and Wednesday June 5 during the lunch block. You will need to attend both sessions to obtain credit, but feel free to attend just one if your schedule is full. And come by for our PWS Information Session and SWSPCP Mixer on Monday evening, June 3. It's always a lot of fun, and we officially pass the torch to the next president at the mixer. I have enjoyed assisting the program as president this year and want to thank the whole Board for working with me. I look forward to welcoming Leandra Cleveland as your next president and Rob Shannon as your next president-elect. Please join us in welcoming **Rob Shannon** as the newly-elected SWSPCP President-Elect. Rob is no stranger to our organization, having been certified as a Professional Wetland Scientist in 1998 and soon after joining the Certification Review Panel until he was appointed as Chair of the Review Panel in 2009. Announcing the Professional Short Course Pre-Approval Program

In 1994, the Society of Wetland Scientists (SWS) formally established the Professional Certification Program (PCP) to certify individuals meeting the requirements as a Professional Wetland Scientist (PWS) or Wetland Professional in Training (WPIT). An individual seeking certification as a PWS must document a minimum of at least fifteen credits hours, or equivalent (US academic standard), of additional education in specialized wetland course work (SWCW). SWCW credit may be obtained through successful completion of graduate or undergraduate course work, collegiate extension courses, or more frequently through professional short courses. In addition, PWSs seeking certification renewal are also required to document additional specialized wetland training.

While the SWSPCP standing rules provide general standards on the types of courses which may be acceptable in meeting the SWCW and renewal requirements, many potential PWS applicants, WPITs seeking to upgrade to PWS, and renewal applicants, are uncertain whether a particular short course will receive the appropriate credit or points. The content of such courses varies widely and in many cases may have little applicability to wetland science. Many potential applicants have felt great uncertainty about expending resources to take a professional short course without having a reasonable expectation that the course would be acceptable to one or both review panels. To address this concern, the Presidents of SWS and SWSPCP established the first ever joint committee to investigate this concern and develop a strategy to provide pre-approval of professional short courses.

The joint Ad Hoc SWS/SWSPCP Wetland Coursework Committee was formally established in the early spring of 2012. The committee consisted of four members from each organization (SWS & SWSPCP) and included representatives from the United States, Taiwan, and the United Kingdom. The committee met at the SWS/SWSPCP annual meeting in Orlando, Florida in 2012 to establish refined goals, minimum potential course and trainer criteria, and projected dates for program development and implementation. In November 2012, the SWSPCP Board approved the recommendations of the joint Ad Hoc SWS/SWSPCP committee and established the Professional Short Course Pre-Approval Program Requirements and Standards, and established the Professional Short Course Review Panel (PSCRP) as set forth in Sections 31 and 32 in the Standing Rules, respectively.

At the January 2013 SWSPCP Board Meeting, initial members of the PSCRP were nominated and approved by the Board. The committee is currently developing the administrative process to implement the program. It is anticipated that the PSCRP will begin accepting applications on or about June 1, 2013.

SWS and SWSPCP believes that implementation of the Professional Short Course Pre-approval Program constitutes an important step forward in providing absolute predictability that a PSCRP-approved professional short course will receive the appropriate credit when an applicant seeks PWS certification or points for certification renewal. Similarly, course proponents, sponsors and instructors can advance their course offerings with a pre-approved underwriting by the SWSPCP.

We, the engineering profession and allied technical community, needs **Our**, the engineering and technical organizations, help to educate engineers, allied technical professionals, and the public regarding engineering credentials – licenses and certifications.

Licensing of engineers has existed for over 100 years (since 1907) and certification of engineers and allied technical specialists for more than 50 years (since 1955). Yet, studies by many organizations have conclusively established that very few of the millions of engineers and allied technical specialists practicing in the United States correctly understand the definitions of the few terms associated with engineering credentials, the appropriate uses of credentials and their benefits to practitioners, employers, and the public.

A task force of individuals representing the National Council of Examiners for Engineering and Surveying (NCEES), the National Society of Professional Engineers (NSPE) and the Council of Engineering and Scientific Specialty Boards (CESB) developed a concise educational document to address this problem. The draft document was thoroughly vetted over four years to ensure accuracy. It is time, after 100 years, to ensure that all properly understand engineering credentials. This can be accomplished if engineering and technical organizations distribute the *Engineering Credentials* document to their members, students, and the public on a continuum. 

Suggested Changes to the 2014 Professional Wetland Scientist Survey

The Society of Wetland Scientists Professional Certification Program (SWSPCP) is accredited by the Council of Engineering and Scientific Specialty Boards (CESB). CESB accreditation requires that the SWSPCP create and maintain a Body of Knowledge (document) that outlines specific skills, knowledge, and abilities that a Professional Wetland Scientist should possess.

The Body of Knowledge (BoK) must be solicited from all who are certified by the program and be updated every five years. The BoK is a living guidance document for knowledge and skill requirements to be used by the SWCPCP Certification Review Panel in assessing an applicant's experience towards certification as a Professional Wetland Scientist.

The Body of Knowledge Survey will be sent to all Professional Wetland Scientists again in 2014. The survey consist of a list of skills, abilities, and knowledge all PWSs could potentially possess in order to be certified as a Professional.
